- 7.1. 2015-16 Enrollment Update Mr. Wendling stated the current student enrollment for the 2015-2016 school year is 185.

- 7.3. Harrisburg PD MoU Mr. Wendling stated that we are still working on getting the Memorandum of Understanding (MoU) signed and approved with the Harrisburg Policy Department.
